- D. The Parties wish to regulate the transferring or sharing of data with UCAM since the party is based in the United Kingdom, which will become a country not member of the European Union.
- E. The parties record their commitment to sharing arrangement under the terms of this Agreement.

The arrangements in the Agreement specify the duties and rights of each partner to fulfill the objectives of the project in compliance with the European legislation in the context of data collection and management.

A precise and complete specification of the following items is listed in the full version of the document (signed by all partners on July 10th, 2021): purpose of sharing data among the partners of the WA consortium, partners in charge of collecting and/or processing data, partners involved in the sharing of the data, description of data items to be collected and/or shared, legal basis for sharing of the data, access and individual rights, information governance, co-operation, transfer of data between parties, transfer of data between Parties and UCAM, data breach interventions, terms and termination, liability.
